Notes on Gift Aid

(Please detach and keep for reference)

- From 6th April 2000, the Government announced new measures to encourage individuals to give to charity which supercedes the covenant scheme and the previous Gift Aid Scheme. One declaration is all that is needed to enable NWET/NISCU to claim back the tax on all your gifts of any amount or frequency.
- The individual signing this form must pay an amount of income tax and/or capital gains tax at least equal to the tax that NWET/NISCU claims on your donations in the tax year (currently 28p for each £1 you give.)

NB: in order to claim the tax back the signature on the Banker's Order Form must be the same as the signature on the Gift Aid Declaration.

- Please notify NWET/NISCU if you change your name or address while the declaration is in force.
- If, in future, your circumstances change and you no longer pay sufficient tax equal to the tax that NWET/NISCU reclaims, you can cancel your declaration by notifying NWET/NISCU. It will then not apply to donations you make on or after the date of cancellation or such earlier or later date you specify.
- If you pay tax at the higher rate you can claim further tax relief in your Self Assessment tax return.
- If you are unsure whether your donations qualify for Gift Aid tax relief, or have any other queries, please contact our head office as below. Alternatively you can ask your local tax office for leaflet IR65 Gift Aid.
